# FIRST AMENDMENT TO AMENDED AND RESTATED DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS NORTHRIDGE PARK II

This First Amendment to Amended and Restated Declaration of Covenants, Conditions and Restrictions for Northridge Park II (the "Amendment") is made by KB HOME Lone Star Inc., a Texas corporation ("Declarant"), and is as follows:

#### RECITALS:

- A. Declarant previously recorded that certain <u>Amended and Restated Declaration of Covenants, Conditions and Restrictions for Northridge Park II</u>, recorded as Document No. 2019018918, in the Official Public Records of Travis County, Texas (the "Declaration").
- B. Pursuant to Section 9.3 of the Declaration, the Declaration may be amended by the Declarant acting alone.
  - C. Declarant now desires to amend the Declaration as set forth hereinbelow.

NOW THEREFORE, Declarant hereby amends and modifies the Declaration as follows:

- 1. <u>Limited or Restricted Driveway Parking</u>. *Section* 2.37 of the Declaration is hereby deleted in its entirety and is replaced with the following:
  - 2.37 <u>Limited or Restricted Driveway Parking</u>. The Association reserves the right to adopt parking rules and regulations within the Property and on any street adjacent thereto. As a result of the required design of the project, driveways constructed on a Lot may not be able to accommodate the parking of vehicles. No vehicle may be parked on a driveway constructed on a Lot if the vehicle, when parked, would obstruct or otherwise block ingress and egress to and from sidewalks adjacent to the driveway, i.e., no portion of the vehicle may extend over a line extended from the rear of one sidewalk adjacent to the driveway to the rear of the other sidewalk adjacent to the driveway. This provision will not apply to Declarant or its designee during the Development Period.
- 2. <u>Miscellaneous</u>. Any capitalized terms used and not otherwise defined herein shall have the meanings set forth in the Declaration. Unless expressly amended by this Amendment, all other terms and provisions of the Declaration remain in full force and effect as written, and are hereby ratified and confirmed.
